How do I get a copy of my child's birth certificate?

Each state has a department of vital statistics where you can order a copy of your child's birth certificate. You have to get the birth certificate from the state in which your child was born.

In Pennsylvania, you can order a copy of your child's birth certificate on line or go to certain vital records centers around the state and order a copy in person. To do this, go to the following website: http://www.portal.state.pa.us/portal/server.pt/community/birth_certificates/14121

If you child was born in another state, search in your computer for *Birth Certificates, (State)*, and you will find the website that instructs you how to order a birth certificate.

How do I get a copy of my Income Tax Records?

Federal income tax records are called Transcripts. It is easy to get a copy of these records on line: http://www.irs.gov/Individuals/Get-Transcript

You will have to provide a Social Security Number or an Individual Taxpayer Identification Number (ITIN). You then may obtain your records electronically or by mail.
